Abstract submission is under way for the STS 54th Annual Meeting, January 27–31, 2018, in Fort Lauderdale, Florida. Submissions for scientific oral presentations, scientific posters, and surgical videos will be accepted until **Friday, June 9, 2017, at 11:59 p.m. Central Time.**

Accepted presentations are printed in the official Annual Meeting *Abstract Book*, and corresponding manuscripts are to be submitted for publication consideration in *The Annals of Thoracic Surgery*, a world-renowned, peer-reviewed journal.
